Debbie has advised that it is classed as urgent works ,we will still get 3 quotes as per normal process. Doing that now.



Item 5. Concerns about how bin area is being used.

On more than a few occasions, items have been left on the top of the bins, perhaps because person is not sure wether its recyclable or not. However, leaving items on the top of the bins is not acceptable because cats ,rats, cockatoos and stormy weather inevitably results with the items being scatter over the bin compound floor.
